

2016 Itasha Exhibitor Agreement

This agreement documents the entire understanding entered into by Sabakon LLC and all approved Sabakon 2016 Itasha Exhibitor Participants. This agreement becomes affective upon confirmation of participation by Sabakon staff.

CONTRACTOR: 2016 Itasha Exhibitor

EVENT: Sabakon 2016

1. SERVICES: Contractor agrees to perform services below in exchange for the compensation noted in Section 2.

Name of Event: Sabakon 2016

Location: Alexis Park Resort (375 E. Harmon Ave, Las Vegas, NV 89169)

Date: August 19, 2016 - August 21, 2016

Contractor agrees to display an approved vehicle on a designated lot at Alexis Park Resort for the duration of the 2016 Sabakon Event. Contractor agrees to having the vehicle on the lot by 8am on Friday, August 19, 2016. Contractor agrees not to remove the vehicle from the designated lot until 6pm on Sunday, August 21, 2016.

2. COMPENSATION: Contractors will receive all of the following in exchange for Services presented in Section 1.

Event Passes: Contractor will be given 2 full weekend event passes to the convention

INDEMNIFICATION: Contractor shall indemnify, save harmless, and defend Sabakon LLC and its staff, members and volunteers, Hansha Studios, and Alexis Park Resort and its officers, employees, and agents from all liability including costs and expenses, for all actions or claims resulting from injuries or damages sustained by any person or property arising directly or indirectly as a result of any error, omission, or negligent act of the Contractor, subcontractor, or anyone directly or indirectly employed by them in the performance of this agreement. All contractors' activities will be at its own risk and contractor is given notice of its responsibility to guard against physical, financial, and other risks as appropriate.
- **4. TERMINATION:** This contract may be terminated at no cost to either party upon 60 days advanced written notice of the Event. This contract may also be terminated in whole or in part in the best interest of Sabakon LLC, or terminated in default if the contractor fails to make delivery of services or perform services within the specified time. Should the Contractor wish to terminate this contract for any reason within 60 days of the Event, the Contractor will be billed for any travel arrangement expenses, including but not limited to flight and hotel room bookings, incurred by Sabakon LLC as a result of the termination of this contract.
- 5. PUBLICITY: Contractor agrees to allow Sabakon LLC and Hansha Studios to use his or her name, likeness, and other recognizable aspects of his or her persona to promote Sabakon online and via print materials including but not limited to flyers, posters, bookmarks, web advertisements, and social media advertisements. Contractor also agrees to allow Sabakon LLC and Hansha Studios to use the likeness of the vehicle in all future marketing campaigns related to the Event.
- 6. NON-DISCLOSURE: This contract and all of its contents are to be kept private between the Contractor and Sabakon LLC and its staff. Contractors may not share any content on this contract with any other parties without the explicit permission of Sabakon LLC.
